5.3. Student Performance and the Unified Improvement Plan (UIP) (Rick Dahlman)

- Scores from this year and previous years have BLA on a plan for monitoring however the current cut points for UIP moving forward is at a higher benchmark so the focus is going to be improving data
- CMAS testing
 - o English Language Arts grades 3-8
 - \circ Math grades 3-8
 - Social Studies grades 4 and 7 on select years
 - Science grades 5, 8, and 11
- As a brief generalization BLA is high achieving and consistently meets state standards but shows approaching in the areas of growth

- Staff Retention
- The major metrics for student progress monitoring is Renaissance (STAR) beginning in second grade which gives information that is normed referenced in ELA and Math but is multiple choice, in writing students are using Collins Writing (BLRA) and ThinkCERCA (BLPA MS), students in elementary are progressed monitored on reading skills using DIBELs

- 5.3.1. MLO Measure 4A:

"The ballot language for 4A asks for an increase of 6.5 mills, which will improve the average compensation disparity by about \$2,500 for eligible D49 staff, by improving the financial disparity between District 49 and D11 / D20 by about half. For context, D49 can significantly improve compensation for our most valuable resource for the cost of a typical meal at most fast-food restaurants, or two beverages from your favorite coffee shop every month."  - Additional funds from General Funds will be used to compensate additional faculty
 - Request a one-time approval of \$80,000.00 for Compensation for Safety and Security at BLA
